### Russell Bedford International celebrates 40 years!



The global accounting, audit and tax network, Russell Bedford International, has reached a monumental milestone, marking its 40th year.

Since 1983, the Russell Bedford group of professional services firms has provided financial expertise and business consultancy to companies and business owners in an array of markets and industries.

Established by London member firm, Lubbock Fine, Russell Bedford International has grown from humble beginnings to become the organisation it is today, one that strives for excellence above all else.

At its inception, Russell Bedford had a modest footprint, setting out with a presence in a handful of countries. Since then, it has seen much change and continued progress, as growth and development took centre stage in the network's strategy.

Geoff Goodyear, who was a driving force behind the network, and served as Chair of Russell Bedford for 18 years from 1996, said: "From small beginnings, the Russell Bedford network has seen impressive growth through the years, bolstered by the appointment of Kempton Bedell-Harper in 2000. Network membership more than doubled in the following ten years and by 2010, Russell Bedford was represented by 81 member firms, while its country presence expanded from 29 to 80 countries."

Quality assurance became a priority in the early 2000s, with the network taking steps to develop an audit quality control system. The organisation successfully implemented a globally coordinated quality assurance programme in 2007, leading to Russell Bedford International being named one of the first full members of the IFAC Forum of Firms in 2008.

In 2013, the network appointed its first CEO, Alan Bezzant and by 2016, it had reached a significant milestone of 100 member firms. Stephen Hamlet succeeded as CEO in 2017, leading to considerable change and further substantial growth in the subsequent five years, including a brand relaunch and creation of Russell Bedford's slogan 'taking you further'.

Laurence Newman, partner at Lubbock Fine and Russell Bedford's finance director on the global board said: "In my extensive association with Russell Bedford, I've enjoyed watching the network grow from strength to strength, while developing great business relationships and friendships along the way. The appointment of Stephen Hamlet has undoubtedly been a great success and he has added another dimension to the development of the organisation."

Today as Russell Bedford continues to grow, it is recognised as a Top 20 global accounting network, with a global fee income of more than USD 750 million. It is represented by 1000 partners, over 9000 staff and some 350 offices in 110 countries.

Colleagues and clients can expect to see further communications, with exciting celebrations to commemorate this very special occasion, throughout the year.

Speaking about the milestone, Russell Bedford's CEO, Stephen Hamlet, commented: "This is a significant moment for Russell Bedford. I feel privileged to be part of a network that is steeped in so much history yet refuses to stay still, continuously flourishing to new heights. I am confident that with our ambitious mindset and with the support of our global colleagues, along with recent new recruits, the Russell Bedford network will continue to see the consistent growth to which it has become accustomed."

Recently appointed Chair, Daniel Ryba, said: "Progress has remained a consistent theme throughout the network's existence, building upon shared values and a common culture. It is a most exciting time to be Chair of this fabulous global organisation. It's a role I take great pride in, and I know that the next chapter is one I look forward to with great anticipation."

### Russell Bedford cares... in Turkey



As a response to the catastrophic earthquakes in East Turkey and as a gesture of solidarity with the network's member firms based in Istanbul and Ankara, Russell Bedford International has donated £5,000 to The Foundation of Anatolian People and Peace Platform (AHBAP Charity).

Recommended by the network's local member firms in Turkey, AHBAP is a leading charity founded to help those in need and has been extremely responsive and supportive in the affected regions of the natural disaster.

On Monday, 6 February 2023, a 7.8-magnitude earthquake hit near the city of Gaziantep just after 4am local time. Numerous aftershocks followed, including one with a magnitude of 7.5 that shook the area the same day in the middle of search and rescue operations.

AHBAP volunteers arrived in the affected areas just hours after the first deadly earthquake and has since worked continuously in coordination with the Turkey Disaster and Emergency Management Presidency, governors' offices and municipalities and local volunteers to rescue as many survivors as possible.

The foundation has provided food, water, tents, generators, mobile trucks for personal hygiene needs, while also organising and announcing institutions and businesses that opened their doors to people who lost their homes after the earthquakes. AHBAP further encouraged and organised people to donate blood for the treatment of tens of thousands injured in the quakes.



In addition to this donation, the network encourages Russell Bedford members, who may feel powerless to the overwhelming human suffering, to support organisations such as AHBAP, who are doing their best to ensure comfort and aid to those in dire need at this challenging time.

Speaking about the devastation, Senior Manager at the Istanbul member firm, Ziya Deniz Şenalp, said: 'The recent earthquakes have devastatingly affected more than 13 million people's lives, with more than 40,000 dead and tens of thousands still under rubble. Even though it is impossible to fully ease the pain for their losses, the focus must now be placed on helping those affected. We are so grateful to hear that Russell Bedford International made a donation from its RB Cares fund this year to support the victims of the earthquake - it will help immensely.'

He added: 'In the accountancy profession, so far, more than 100 CPAs and CPA candidates are identified as having lost their lives, and more than 1000 CPAs have lost their homes and offices. As the network's member firm in Istanbul, it is our obligation to help them in any way possible. We have made a donation and are planning to provide jobs and shelter to those directly affected. We are encouraging all member firms to join in this effort.'

Aslan Kaya, Partner at the Ankara member firm, further expressed: "It is painful to see, innocent lives were sacrificed yet again. Amongst this devastation, what brings us hope is the vast support we have received from over 100 countries and thousands of organisations, like Russell Bedford International. Our people are deeply grateful to those who stand in solidarity with us, so we rebuild our future together."

Russell Bedford CEO, Stephen Hamlet commented: "When we first established the 'RB Cares' initiative, we had no idea what situations would arise around the world in years to come. Unfortunately, each year there are always a number of causes that desperately need help; whether these be due to natural disaster, economic downfall or a crisis requiring humanitarian aid. When we started seeing video footage of the devastation in Turkey and Syria, caused by the earthquake in early February this year, it was heart-breaking. We reached out to our Russell Bedford colleagues in Ankara and Istanbul and, although they were safe and not directly affected, it was clear that this had a terrible impact on the whole country, and we knew we had to do something. "

Stephen continued: "Every year when we make a contribution through our 'RB Cares' campaign, however small in the scheme of things, it makes me proud that we are doing a little something and, together with others, we can really make a difference. This year Russell Bedford is helping in Turkey and we pray for all those who have suffered so significantly."

### FINANCIAL REPORTING

#### Proposals to update the IFRS for SMEs Accounting Standard

The International Accounting Standards Board <u>published proposals to update the IFRS for SMEs Accounting Standard</u>, to reflect new requirements and improvements that have been made in full IFRS Accounting Standards since the last edition of the standard published in 2015, while keeping it simple for small and medium-sized entities. The proposals also respond to feedback from stakeholders and advice of the SME Implementation Group.

The comment letter period is open until 7 March 2023.

#### SUSTAINABILITY REPORTING

#### State of play in sustainability reporting and assurance

The International Federation of Accountants (IFAC) published a report on <u>The state of play: sustainability disclosure &</u> <u>assurance.</u> The report presents the 2019-2021 trends and analysis from an <u>ongoing benchmarking study</u> of global practice in sustainability disclosure and its assurance. The study captures and analyses the extent to which companies are reporting and obtaining assurance over their sustainability disclosures, which assurance standards are being used, and which companies are providing the assurance service.

#### AUDIT

### Technology-focused FAQ published by IAASB

The Technology Consultation Group of IAASB released <u>non-authoritative support material related to technology</u> to help address certain frequently asked questions (FAQ) about investigating exceptions and the concept of performance materiality, when performing audit procedures using automated tools and techniques for analysing data sets with large volumes of information.

The publication does not amend or override the authoritative texts of the International Standards on Auditing (ISAs).
